1. INTRODUCTION

Pursuant to the Markets in Financial Instruments Directive 2014/65/EU and the Commission Delegated Regulation (EU) 2017/565, (collectively **"MiFID II"**) and in accordance with the Investment Services and Activities and Regulated Markets Law of 2017 (the **"Law"**) of the Cyprus Securities and Exchange Commission (**"CySEC"**), ECOMMBX Investments Ltd (ex Mercorix Ltd) (the **"Company"**) has an obligation to inform its Customer (**"you"**), before the provision of services, about the fees (or interchangeablyand associated fees) that relate to investment services and/or ancillary services offered by the Company. This is done in order to ensure the Customer's awareness of and associated fees to be incurred as well as to enable the Customer to evaluate such information and compare with different financial instruments and investment services, further to the information already provided in the investment services Terms and Conditions.

Two types of disclosures will be made to the Customer:

(i) On an ex-ante basis (i.e. before you trade) disclosures of aggregated expected and associated fees for the relevant investment service and financial instrument

(ii) On an ex-post basis (i.e. after you trade), disclosures of aggregated and associated fees that have actually been incurred by you for the relevant investment service and financial instrument. This will be provided to you annually on a personalised basis

2. INVESTMENT SERVICES AND ASSOCIATED FEES

The tables below presents the sssociated fees for the financial investment services and instruments offered:

- Table 1: Brokerage services
- Table 2: Investment advice services

In relation to the brokerage services (table 1) and for each of the financial instrument categories, we will show separate figures comprising:

- Entry Fees which may include one-off, incidental, transaction and ancillary services fees which occur upon entry
- Running Fees which may include on-going, incidental, transaction and ancillary services fees

• Exit Fees which may include one-off, incidental, transaction and ancillary services fees which occur upon the sale of a financial instrument
